Canada

- The S&P/TSX Composite decreased 0.10% on the week led by a 2.78% decrease in the Information Technology sector.
- According to Statistics Canada the Canadian economy added about 100 positions in December, while the unemployment rate held steady at 5.8%. Despite the slight increase in jobs wage growth for permanent employees accelerated to 5.7% on the month the strongest pace since January 2021.

United States

- The S&P/500 Composite decreased 1.52% on the week.
- According to the Labor Department US employers added 216,000 jobs in December leaving the unemployment rate was unchanged at 3.7%.
