Canada

- The S&P/TSX Composite decreased 3.77% on the week, led by the Energy sector which decreased 12.79%.
- Housing starts rose from 166.5K in April to 193.5K in May (seasonally adjusted and annualized). Urban starts improved (+22K) to 181.1K given an increase in both the multi segment (+14.9K to 135.9K) and the single-detached units portion (+7.1K to 45.3K). At the provincial urban level, starts in Quebec rose from 0K in April to 56.3K in May but this jump was partially offset by a 37.1K decline in Ontario (to 56.5K). Elsewhere starts rose 8.5K in B.C. and fell 8.1K in the Prairies (see chart on the right).

United States

- The S&P/500 Composite decreased 4.78% on the week.
- With GDP collapsing in the first half of 2020, the output gap has quickly turned from positive to
 negative in the U.S. As such, it's not surprising prices are now declining. The consumer price
 index fell for a third month in a row in May in seasonally adjusted terms, both for the headline
 index and the core measure i.e. excluding food and energy.
