

#### Canada

- The S&P/TSX Composite increased 1.46% on the week, led by an increase of 11.06% in the Health Care sector.
- A new report from the Royal Bank of Canada finds Canadians are in splurging mode and are spending 20% above 2019 levels. This higher spending is partly an outcome of rising prices and supply chain bottlenecks, as inflation rates in Canada stand at 4.4% in September, their highest level since 2003.

#### **United States**

- The S&P/500 Composite decreased 0.31% on the week.
- US consumer prices rose last month at the fastest annual pace since 1990. The consumer price
  index increased 6.2% from October 2020, according to the Labor Department. Higher prices for
  energy, shelter, food and vehicles fueled the reading.
- The University of Michigan Sentiment Index fell to its lowest level since. Consumers can expect
  inflation to rise 4.9% over the next year, and expect prices to rise 2.9% over the next five to 10
  years.
